

BOW CRAFTING WORKSHOP AGREEMENT

The objective of this agreement is to specify the terms of organization of a bow crafting workshop in order to avoid any misunderstanding between the beneficiary and the organizer of the workshop, Falcon archery. Before starting the workshop sessions, the beneficiary and the organizer must read this document, sign it and agree to respect its articles until the completion of the process. In the event of non-compliance with these articles by either party, the collaboration will end with immediate effect.

Art. 1

Falcon archery undertakes to welcome the beneficiary and guide him/her during the manufacturing process of a 54" recurve bow. Falcon archery provides the beneficiary with all the necessary tools and raw materials. The beneficiary will be able, to a certain extent and depending on the materials available, to choose from several types of wood for the riser and the veneer of the limbs. If desired, the beneficiary can integrate a symbol made with a laser on the overlay of the bow riser.

Art. 2

The beneficiary undertakes to scrupulously follow Falcon Archery's instructions in order to ensure the best chance of success in the manufacturing process.

Art. 3

Falcon archery undertakes to allow the beneficiary to carry out as many steps as possible. However, Falcon archery reserves the right to intervene as much as necessary to ensure the completion of certain particularly delicate stages.

Art. 4

The production of very short recurve-type glued laminated bows being particularly complicated, Falcon archery cannot guarantee that the process will be completed. Falcon archery will, however, do everything possible to ensure maximum chances of success. If the bow currently being manufactured cannot be finalized for one reason or another (problem during gluing, breakage, twisted limb, etc.), Falcon archery will offer the beneficiary to start the process again. The beneficiary will have complete freedom to accept this proposal or refuse it.

Art. 5

Falcon archery will do everything possible to ensure that the finalized bow comes as close as possible to the weight desired by the beneficiary. However, Falcon Archery cannot guarantee that the final weight of the bow will be accurate.

Art. 6

At the start of the process, both parties will agree on a common pace of work and establish a work program. Still in order to increase the chances of success, the beneficiary is not authorized to work alone on his/her bow (subject to explicit authorization from Falcon archery).

Art. 6

The basic hardware kit includes wood for the riser, bamboo laminations, limbs veneer, epoxy glue, varnish, consumables (abrasives, tape, etc.), a flemish twist string with 4 silencers and the access (as well as depreciation) to machines and tools. This basic hardware kit has a value of CAS 290 and must be paid for by the beneficiary before the start of the first day of work. If certain steps must be redone a second time, Falcon archery will provide the beneficiary with additional materials which will be paid for in addition.

Art. 7

The beneficiary may decide at any time to refuse to continue the process. In this case, the basic hardware kit will remain the property of the beneficiary and he/she will be able to dispose of it as he/she wishes. Falcon archery also has the same freedom to terminate the process.

Art. 8

Falcon archery will be paid CAS 290 per day of work (8 hours/day). As beneficiaries require more or less time to finalize their bow, it is not possible, at the start of the process, to determine the exact number of working days necessary. Falcon archery will send invoices every 2 months counting the number of days of work carried out during the previous 2 months.

Art. 9

The beneficiary undertakes to pay for the basic hardware kit, as well as the bimonthly invoices, within 15 days after receipt of the invoices. In the event of non-payment, no additional days of work will be provided by Falcon archery.

Art. 10

Falcon archery will equip the beneficiary with all the necessary protective equipment, except for a protective mask and gloves which must be purchased by the beneficiary for hygiene reasons. Falcon archery will give him/her all the useful safety instructions. The beneficiary undertakes to use protective equipment and to respect the safety instructions. In the event of an accident, Falcon Archery cannot be held liable under any circumstances, nor that of Saltspring Archery Society (SAS) or Mr. Brian Matheson in person who provides the manufacturing workshop.

Art. 11

If the beneficiary wishes to make other objects (leather satchel, quiver, arrows, string, etc.), Falcon archery can offer him/her other additional guided workshop sessions at the same price as that stipulated in art. 8.

Art. 12

In the event of an impediment, the beneficiary is asked to notify Falcon archery at least 72 hours before the planned working day. If the announcement occurs within 48 hours, 50% of the daily rate will be due by the beneficiary. If the announcement is made 24 hours before the working day, the entire daily rate will be due by the beneficiary.

If Falcon archery, for one reason or another, cannot provide a scheduled working day, it will inform the beneficiary as soon as possible. If the announcement is made 48 hours before, Falcon archery will reduce its salary by 25% the following day. If the announcement is made 24 hours before, Falcon archery will reduce its salary by 50% the following day.

Art. 13

It is the responsibility of the beneficiary to ensure his/her food during the working days. Toilets and a parking space will be made available to the beneficiary during all working days.

Art. 14

Falcon archery assumes no responsibility linked to the use of the bow made following its manufacture (breakage, injury, illegal hunting, etc.).

Art. 15

Falcon archery will provide a copy of the agreement signed by both parties before production of the bow begins.

Art. 16

Falcon archery is committed to guiding the beneficiary in a caring manner. The beneficiary is also expected to show leniency towards Falcon archery. Bow making is an activity that can be complicated. Falcon archery does not claim to be capable of carrying out all operations perfectly in 100% of cases. To avoid any frustration, a moment will be taken at the start of the process to allow the beneficiary and Falcon archery to clarify the level of perfection possible and expectations in terms of the final result.

Art. 17

The beneficiary authorizes Falcon archery by default to take photos and videos during the production of the bow illustrating the beneficiary at work. These photos and videos may subsequently be used for promotional purposes by Falcon archery. Falcon archery undertakes to provide copies of these documents to the beneficiary if he/she requests them. The beneficiary can ask that his/her anonymity be ensured by simple verbal request at the start of the process in order to avoid any photo or video taking.
